

ACKNOWLEDGMENT OF RISK/RELEASE AND HOLD HARMLESS AGREEMENT

Important Legal Document: Read carefully before signing

I, the undersigned, participant (and/or parent, individually and on behalf of the minor participant) hereby acknowledge that I have voluntarily elected to participate in or enroll in (*North DeSoto Wrestling "Camp of Champs"*) offered by the DeSoto Parish School Board in conjunction with the educational program at North DeSoto Campus Schools. I am aware of the content area/physical requirements of the program and understand the risks involved in the same. I recognize that the activities involve a risk of injury, and I agree to accept all risks associated with it, including, but not limited to, minor bodily injury, severe bodily injury, loss of use or total loss of limb, paralysis and/or death. I am not aware of any medical condition that may adversely affect my ability to participate or, if suffer from any condition, I have been cleared for participation by my physician. I require no unique or special accommodation to insure my safety.

In consideration of my participation in such program and to the fullest extent permitted by law, I (and my parents) agree to release, indemnify, defend, and hold harmless the DeSoto Parish School Board, its members, officers, employees, agents, insurers, volunteers, and assigns from and against all claims arising out of or resulting from my participation in the program and any injuries I may sustain. "Claim" as used in this agreement means any financial loss such as medical bills, insurance claim, lawsuit, action, damage, or expense, including, but not limited to, those resulting from bodily injury, sickness, disease, or death, or illness, including loss of use resulting therefrom, as well as any and all attorney fees incurred by the school board. I further understand that this acknowledgment of risks and hold harmless agreement is intended to be as broad and inclusive as permitted by the laws of the State of Louisiana and that if any portion hereof is held invalid, that provision is subject to severance, and that the balance of the agreement shall, notwithstanding, continue in full legal force and effect.

I agree that this acknowledgment and hold harmless agreement is effective for as long as I participate in the program. I also agree to abide by any and all policies adopted by DeSoto Parish Schools regulating my role as a student and as a participant in the subject program.
